1 Introduction

The information provided in respect of individual care homes i.e. address details, service user groups, home categories, number of beds is based upon information obtained from the Care Quality Commission (CQC) and individual care homes. All care homes included on the list are registered with CQC. The home information will also indicate contact details including whether the home has an email address and whether the home is a private home (Independent) or a Council home (Local Authority).

Information on registered provision can change frequently and whilst every effort has been made, it cannot be assumed to be totally correct. You are therefore advised to check with the appropriate CQC Office to establish that the care home holds the appropriate registration, before agreeing to any placement.

3 Care Home Standards

All care homes must, by law, be registered with CQC and are measured against a set of national minimum standards on a regular basis. This forms an overall judgement that identifies the home as:-

- 3* Excellent
- 2* Good
- 1* Adequate
- 0* Poor

The Council recognises and rewards care homes that have achieved excellent and good status.

In respect of nursing home placements, you will be eligible for NHS funding to contribute towards the cost of your nursing care. This will be payable by the local Primary Care Trust (PCT).

The care home's charge may be over and above the amount the Council would usually be prepared to pay (the Council's usual rate). The 'difference' (so called a '**Top Up**') generally must be paid for by a third party e.g. relative or friend.

5 Contracts

The listing below also indicates whether or not the care home has agreed and signed a contract with the Council to provide care in its home.

If the care home has a 'No' in the column headed 'Contract' then this indicates that it has not accepted the Council's usual terms and conditions. Under such circumstances, the Council, at its discretion may seek an alternative placement at another home.

All contracts must be agreed and signed before any placements can be funded by the Council
