1 Introduction

The information provided in respect of individual care homes i.e. address details, service user groups, home categories, number of beds is based upon information obtained from the Commission for Social Care Inspection (CSCI) and individual care homes. All care homes included on the list are registered with CSCI. The home information will also indicate contact details including whether the home has an email address and whether the home is a private home (Independent) or a Council home (Local Authority).

Information on registered provision can change frequently and whilst every effort has been made, it cannot be assumed to be totally correct. You are therefore advised to check with the appropriate CSCI Local Office to establish that the care home holds the appropriate registration, before agreeing to any placement.

However as vacancies can change daily it is recommended that you contact the care home directly for this information.

3 Care Home Standards

All care homes must be by law, registered with CSCI and are measured against a set of national minimum standards on a regular basis. This forms an overall judgement that identifies the home as:-

Poor  
Adequate  
Good  
Excellent

The Council also operates a Contracting for Quality Scheme that recognises and rewards care homes that have achieved externally accredited quality assurance award. The scheme is administered by an organisation, which is independent of both the Council and CSCI and is designed to advance the quality of service delivery and performance. The scheme is called:-

RDB (Residential and Domiciliary Benchmarking)

Under the scheme, Care homes are evaluated annually by RDB, a national objective assessor, who assess all aspects of providing a residential care

service and ultimately give a 'star rating' between 2\* and 5\* (2\* being the lowest, 5\* being the top award achievable)

Participation in the award is optional to contracted providers. It is not intended to replace national minimum standards.

If a care home has participated in the RDB scheme for 2008/09 they are given a 'star' rating and the higher rating achieved, the Council will pay a higher premium. The listing below indicates the level of 'star rating' each home has been awarded (see column headed 'Quality Award')

#### 4 Fees and Charges (including Top Ups)

The levels of funding that the Council has generally made available for care home placements for older people for 2008/2009, the Council's usual rate or Base rate plus payments for achieving quality star rating, are as follows:-

The care home's charge may be over and above the amount the Council would usually be prepared to pay (the Council's usual rate). The 'difference' (so called a '**Top Up**') generally must be paid for by a third party e.g. relative, family friend.

#### 5 Contracts

The listing below also indicates whether or not the care home has agreed and signed a contract with the Council to provide care in its home.

If the care home has a 'No' in the column headed 'Contract' then this indicates that it has not accepted the Council's usual terms and conditions.

The Council may seek alternative placements with a home at its discretion

All contracts must be agreed and signed before any placements can be funded by the Council
